## BASS PRO SHOPS AND CABELA'S \$10K COOKOUT CODE RULES

THE BASS PRO SHOPS AND CABELA'S \$10K COOKOUT CODE CONTEST (THE "CONTEST") IS INTENDED TO BE CONDUCTED IN THE PROVINCES OF BRITISH COLUMBIA, ALBERTA, MANITOBA AND ONTARIO ONLY AND SHALL BE CONSTRUED AND EVALUATED ACCORDING TO APPLICABLE CANADIAN LAW. NO PURCHASE IS NECESSARY. PARTICIPANTS MUST BE OF THE AGE OF MAJORITY IN THE PROVINCES OF BRITISH COLUMBIA, ALBERTA, MANITOBA OR ONTARIO OR OLDER AT THE TIME OF ENTRY. VOID IN WHOLE OR IN PART WHERE PROHIBITED BY LAW. ENTRY IN THIS CONTEST CONSTITUTES ACCEPTANCE OF THESE CONTEST RULES (THE "CONTEST RULES").

- 1. **ELIGIBILITY.** To be eligible for this Contest, an individual must:
  - (a) be a legal resident of the provinces of British Columbia, Alberta, Manitoba or Ontario; and
  - (b) be of the age of majority in their province or territory of residence or older at the time of entry.

- (b) The Grand Prize has an approximate value of ten thousand Canadian dollars (CDN \$10,000.00).
- (c) Secondary Prizes. There are one hundred and five (105) secondary prizes (each, a "Secondary Prize") available to be won by the Secondary Prize winners (the "Secondary Prize Winners"), each of which consists of: one (1) CDN\$50.00 gift card to Bass Pros Shops & Cabela's Canada.
- (d) Grand Prize and Secondary Prizes are hereafter collectively referred to as "**Prize**" or "**Prizes**". Grand Prize Winner and Secondary Prize Winners are hereafter collectively referred to as a "**Winner**" or "**Winners**".
- (e) Winners are not entitled to monetary difference between actual Prize value and stated approximate Prize value, if any.
- (f) The Sponsors and/or the Sponsors' representatives will contact the Winners to coordinate the provision of the Prize(s) within two (2) business days once such Winners have been successfully contacted and notified of his/her Prize and fulfilled the requirements set out herein.

#### 5. PRIZE CONDITIONS.
